- 2 (9:07 a.m.)
- 3 CHAIRMAN LEVI: Institutional Advancement
- 4 Committee members, please raise your hands. All right.
- 5 We have a quorum, and the meeting is in order. And
- 6 Atitaya is walking around, but nevertheless, she
- 7 noticed the meeting in the Federal Register, didn't
- 8 you, Atitaya?
- 9 MS. ROK: Yes.
- 10 CHAIRMAN LEVI: Okay. And therefore, we are
- 11 now in order.
- MS. BROWNE: John, this is Sharon, I'm on the
- 13 phone.
- 14 CHAIRMAN LEVI: Sharon is on the phone but
- 15 you're very faint. Could we do something about that on
- 16 this end? We're making an adjustment so you won't be
- 17 quite so faint.
- MS. BROWNE: Okay. Thanks.
- 19 CHAIRMAN LEVI: There we go. Could I have a
- 20 motion to approve the agenda?
- 21 MOTION
- 22 DEAN MINOW: So moved.

- 1 FATHER PIUS: Seconded.
- 2 CHAIRMAN LEVI: All in favor?
- 3 (A chorus of ayes.)
- 4 CHAIRMAN LEVI: Then a motion to approve the
- 5 minutes of the open session from January 26?
- 6 MOTION
- 7 DEAN MINOW: So moved.
- 8 FATHER PIUS: Seconded.
- 9 CHAIRMAN LEVI: Any issues there? Second.
- 10 All in favor?
- 11 (A chorus of ayes.)
- 12 CHAIRMAN LEVI: Now, where is Wendy Rhein? My
- 13 pleasure to introduce our new director of institutional
- 14 advancement. I don't know, isn't that what we're going
- 15 to call you, or chief development officer? Okay. But
- 16 we might change that to chief institutional advancement
- 17 officer after I negotiate that.
- 18 Wendy Rhein, who starts officially on what
- 19 day?
- MS. RHEIN: May 6th.
- 21 CHAIRMAN LEVI: May 6th. And thank you for
- 22 being with us.

- 1 (Applause)
- 2 CHAIRMAN LEVI: And as long as you're here,
- 3 why don't you come up here just so that if you decide
- 4 you want to weigh in on something -- yes,
- 5 certainly -- because even before May 6, we assume you
- 6 might want to say something now and then about a couple
- 7 of the issues.
- 8 So our Committee, both in open and in closed
- 9 session, has been talking about the fact that next year
- 10 is our 40th anniversary. And we know, based on the
- 11 inevitable declining percentage of life that every year
- 12 seems like it goes faster, that that will be here
- 13 before we know it.
- 14 So our Committee has been talking about how
- 15 to, A, get the 40th anniversary properly funded
- 16 privately, really, a privately funded celebration
- 17 during the year; and to help design an appropriate
- 18 series of events, conferences. This is not a
- 19 social -- there will be some social aspect, but this is
- 20 a moment in time for reflection and how we build a
- 21 quality 40th anniversary so that we can really address
- 22 many of the issues that are out there.

- 1 So in the board book, or maybe it was right
- 2 after our last telephonic -- our Committee has been
- 3 meeting by telephone every two weeks. Most of those
- 4 sessions have been closed because they have been
- 5 actually looking at lists of names of possible funders,
- of possible honorific individuals who could help us.
- 7 But we thought that -- and so I pass around
- 8 for the Committee's consideration this articulation of
- 9 what we might try to raise money for for the 40th year
- 10 for the purpose of presenting it to the Board tomorrow.
- 11 Because it seems to me that when a committee of the
- 12 Board wishes to embark on a fundraising effort, it
- 13 ought to be one that satisfies the Board as well, and
- 14 that ought to have public scrutiny.
- So that is why you have this document in front
- 16 of you. It is one that our Committee discussed in its
- 17 last session and actually worked on the prior couple of
- 18 sessions to bring to this state, and ask if there's any
- 19 comments, changes, suggestions relating to the document
- 20 before we then, I think, actually vote to forward it to
- 21 the Board for consideration.
- 22 Any members of the Committee have input?

- 1 Concern? Suggestions? Charles?
- MR. KECKLER: I have a question. I obviously
- 3 don't object to us forwarding it to the Board. But
- 4 what then do we contemplate the Board will then do with
- 5 it? What are we expecting the next step to be if the
- 6 Board were to accept this?
- 7 CHAIRMAN LEVI: We'll all become fundraisers.
- 8 No, I'm just kidding. No, the next step would be that
- 9 once those objectives are authorized, then we will have
- 10 to put together a -- either the Committee itself can
- 11 decide it's going to undertake it with Wendy, or Wendy
- 12 and those that wish to and feel that they are able to
- 13 will extend themselves to try to bring this to
- 14 fruition. That's really how it would work.
- But I don't think -- this is using a -- I have
- 16 to go back on my own experience here, Charles. And
- 17 Martha may have some idea about this. Normally, when
- 18 an institutional embarks on a fundraising campaign, it
- 19 doesn't just through a committee of the board without
- 20 having the board itself say, you know, that's a good
- 21 idea. We accept that as a series of things because
- 22 otherwise you could have a committee off doing -- we

- 1 don't want that kind of thing.
- 2 So my own training in this is the Board
- 3 ratifies objectives, and then it's up to the
- 4 Institutional Advancement Committee with the director,
- 5 the chief development officer, and the President of the
- 6 Board -- I mean, President of LSC -- to execute.
- 7 MR. KECKLER: So then to follow up, the idea
- 8 would be that after the Board signs off on these broad
- 9 objectives as appropriate goals for the Corporation to
- 10 fundraise, the Committee and staff would, within these
- 11 areas, develop particular concept papers and proposals
- 12 and begin the process of shopping those out to
- 13 potential funders for their interest.
- 14 CHAIRMAN LEVI: Correct. That's right.
- 15 MR. KECKLER: Okay.
- 16 CHAIRMAN LEVI: And there's even pyramids.
- 17 You can design pyramids, how many you need at this
- 18 level to get to this. And our Committee, in its closed
- 19 session, has been looking at names of possible -- we
- 20 think it's possible, or we wouldn't have brought
- 21 these -- that's the other sort of chicken/egg aspect.
- 22 We think it's possible.

- 1 DEAN MINOW: Research?
- 2 CHAIRMAN LEVI: Yes. So we wouldn't be
- 3 suggesting that we try for this if we didn't think we
- 4 had some reasonable chance of being successful.
- 5 Any other -- so if there are none, maybe we
- 6 could have a motion to forward this to the board?
- 7 PROFESSOR VALENCIA-WEBER: I'm not on the
- 8 Committee, but I read the summary. And what I want to
- 9 suggest is something related to the anniversary
- 10 celebration.
- I was wondering if there could be an effort
- 12 made to document and create an exhibit of what LSC has
- 13 done in its 40 years. I raise this because currently
- 14 there's a number of these efforts going on, including
- in my own state, which is a new state, comparatively
- 16 speaking.
- 17 There is a major effort to document what was
- 18 the development of the legal profession and the courts
- 19 in New Mexico, while many of our pioneers were still
- 20 alive.
- We no longer have Mr. McCalpin. But the point
- 22 is that an effort was made with some professional

- 1 historian staff, and a lot of it has been put out as
- 2 part of the graduate students in history and in the law
- 3 school and others doing it for course credit and other
- 4 things.
- I think if we had our celebration with this,
- 6 we could do a lot. For instance, Mr. Fortuno is
- 7 leaving us. And before he leaves, you should have an
- 8 extensive program of recorded interviews so that we
- 9 have his knowledge as well as all of his knowledge
- 10 about where in the closets and other places in this
- 11 building are hidden the pictures and documents relevant
- 12 to the history.
- 13 CHAIRMAN LEVI: Well, he's leaving but not
- 14 going anywhere. So we'll be able to find him.
- But let me just speak to that. First of all,
- 16 I think that's an appropriate observation at the board
- 17 meeting.
- 18 PROFESSOR VALENCIA-WEBER: Okay.
- 19 CHAIRMAN LEVI: Secondly, I think it's covered
- 20 by outreach on page 3, and I don't think that each one
- 21 of those types of things in specific will be
- 22 articulated in the overall concept paper. But I do

- 1 understand that.
- Yes, Martha?
- 3 DEAN MINOW: I just wondered -- it's in the
- 4 spirit of Gloria's comments -- as we think about a
- 5 celebration, the difficulties of the funding moment,
- 6 our desire to raise funds, of course are a context.
- 7 But I wonder if it would be better if the tone
- 8 were set in the form of honoring people who have worked
- 9 in this field, and honoring people who have been prior
- 10 presidents, prior board members, as well as people in
- 11 neighborhood offices, and using their stories as a way
- 12 to tell the story.
- 13 CHAIRMAN LEVI: Again, I think that's a part
- 14 off the outreach effort here at --
- DEAN MINOW: Well, I understand. I
- 16 understand. But it's not so much outreach as
- 17 it's -- I'm really raising the question about the tone
- 18 of this event. The tone --
- 19 CHAIRMAN LEVI: Well, this is not -- okay.
- 20 I'm sorry, Martha.
- DEAN MINOW: Yes. Okay.
- 22 CHAIRMAN LEVI: This is not one event. This

- 1 is the whole --
- 2 DEAN MINOW: Got it.
- 3 CHAIRMAN LEVI: Yes. I understand that. But
- 4 this is not one event. This paper was designed to
- 5 articulate a whole series of things that could be done
- 6 in connection with the 40th as a whole year-long
- 7 effort. One of the events could be, in fact, what
- 8 you're talking about. I agree with that. But I didn't
- 9 mean to cut --
- 10 DEAN MINOW: That's fine.
- 11 CHAIRMAN LEVI: Was that helpful, or no?
- 12 DEAN MINOW: No. I'm looking at the first two
- 13 paragraphs describing the celebration, and it's put in
- 14 the form of, this is a fundraiser for these new
- 15 initiatives. And I'm suggesting that I think a better
- 16 tone is what I described.
- 17 CHAIRMAN LEVI: I see. That paragraph and the
- 18 way it's written actually is -- what maybe should have
- 19 happened is -- you all are thinking that's the preamble
- 20 to the whole document. It's not. It's itself one of
- 21 the objectives. Then the next thing is an objective.
- 22 Then the next thing is an objective.

- 1 DEAN MINOW: I see.
- 2 CHAIRMAN LEVI: And the next thing is an
- 3 objective. So that maybe this one should be tweaked a
- 4 bit. I think it should be, and I'd be happy to have
- 5 the input as it relates to that. And maybe the two of
- 6 you have a suggestion. But it's not the
- 7 overall -- this shouldn't be read as the preamble to
- 8 the whole document.
- 9 MR. KECKLER: We could just put numbers in
- 10 front of them.
- 11 CHAIRMAN LEVI: Yes.
- 12 MR. KECKLER: One, two, three, four, five.
- 13 DEAN MINOW: Yes. That would do it.
- 14 CHAIRMAN LEVI: Yes. That's what our
- 15 Committee meant, yes. We didn't want to have -- if we
- 16 were going to have a two-day conference or whatever, we
- 17 thought that should be privately funded, that we could
- 18 raise the funds for that.
- 19 But obviously, research and pro bono
- 20 innovation fund, that's not about a weekend or a
- 21 two-day event or events around the country. Because I
- 22 also mentioned to Gloria I thought, for example, the

- 1 issues that we talked about yesterday, confronting the
- 2 tribes and our own relationship to them, that's worthy
- 3 of a day-long something closer to where it would be
- 4 convenient for the tribes. Well, that's not this
- 5 weekend, but that's some other event.
- And could we raise funds to support that kind
- 7 of effort? Gloria was saying how difficult it is for
- 8 the individuals involved and knowledgeable to get
- 9 together. They need time. They need planning. They
- 10 need funds to make that possible.
- 11 So how we design a thoughtful year that helps
- 12 to educate not only our programs but also the public at
- 13 large, the bar, about what's at stake, thoughtfully
- 14 done -- I look forward to your input on those things.
- 15 And maybe it isn't just a 40th weekend.
- 16 Yes?
- 17 MS. REISKIN: Yes. Two things. I'd like to
- 18 see some involvement of clients because without
- 19 clients, we don't have any of this. So I think that
- 20 there needs to be a client component to
- 21 everything -- or not maybe everything, but many of the
- things, and then maybe some event or training

- 1 for -- like client board members.
- They've been really craving and wanting more
- 3 training and more involvement. And I'd offer to help
- 4 in any way I can. But I think we've got to have some
- 5 client involvement in this, too.
- 6 CHAIRMAN LEVI: It sounds like you just
- 7 volunteered to raise some money for that. You've got
- 8 to put your money where your --
- 9 DEAN MINOW: We all have to work on it.
- 10 CHAIRMAN LEVI: That's right. We will. But
- 11 I'm serious about that.
- MS. REISKIN: Yes.
- 13 CHAIRMAN LEVI: Because the best people to
- 14 actually raise the funds are people who are
- 15 knowledgeable and, in a sense, represent an area.
- MS. REISKIN: I'm happy to.
- 17 CHAIRMAN LEVI: Anybody on the phone?
- 18 (No response.)
- 19 CHAIRMAN LEVI: So remember, the issue in
- 20 front of the Committee is, do we forward this document
- 21 to the Board for its consideration?
- 22 //

- 1 MOTION
- 2 MR. KECKLER: I so move.
- FATHER PIUS: Second.
- 4 CHAIRMAN LEVI: All in favor?
- 5 (A chorus of ayes.)
- 6 CHAIRMAN LEVI: Okay. I think maybe that was
- 7 actually a merger of 3 and 4. So maybe we
- 8 should -- and I think there were comments from some
- 9 committee members and members not on the Committee
- 10 about the 40th anniversary celebration.
- But your ideas are welcome here, and we'd be
- 12 happy to take them down, although I would say that the
- 13 Institutional Advancement Committee, so that the Board
- 14 understands this, those of you who are not on it, meets
- 15 every two weeks at a regular time. And I don't think
- 16 there's any topic more important than this one.
- 17 That's our current topic. Obviously, we've
- 18 been waiting for Wendy to arrive, and she will help
- 19 guide us, along with Jim, on this. Already we've heard
- 20 a couple of very valuable ideas from Martha and Gloria
- 21 and Julie. I'm sure there will be others. And I would
- 22 ask the Board to forward those by email to our

- 1 Committee or to me and I'll make sure they're discussed
- 2 actively.
- 3 Any other ideas on number 3? Because I guess
- 4 I jumped ahead and did 4 ahead of 3. Maybe that was
- 5 the proper order, too. But I apologize for that. So I
- 6 shouldn't have cut you off.
- 7 DEAN MINOW: That's okay.
- 8 MR. KECKLER: I think there's one thing, John,
- 9 which is we've talked about this in the Committee, and
- 10 we aren't going to necessarily decide this today, but
- 11 the question of when is the big day? And now we're
- 12 less than a year away from being well in 2014.
- So to work this back, and also -- particularly
- 14 if we're going to get certain people for keynotes and
- 15 things like that, it's not too early to think about
- 16 what day we're really thinking about.
- 17 CHAIRMAN LEVI: Yes.
- 18 MR. KECKLER: So I think that's one of the
- 19 early things that we need to think about, is to go
- 20 ahead and pick a day for the 40th anniversary, the main
- 21 celebration, although we can obviously have other
- 22 events. But there's going to be some kind of main

- 1 event.
- 2 CHAIRMAN LEVI: Well, what I was hoping is
- 3 that between now and our July board meeting, that we
- 4 would come up with a calendar and then be in a position
- 5 in the July board meeting to present it.
- 6 My own personal -- just to say I envision a
- 7 yearlong thing, with the opening being at April of next
- 8 year and the close being April of the following year,
- 9 because the day, in a sense, is right in the middle of
- 10 that, sort of.
- 11 It's in, unfortunately, the end of July or
- 12 August, early August, when we were actually signed into
- 13 law. Now, if anybody would like to pick a somewhat
- 14 more moderate time in terms of the temperature, but
- 15 that's sort of around when it is. I don't know that
- 16 that's the day, though. Does it actually have to be on
- 17 the 40th day?
- 18 DEAN MINOW: No.
- 19 CHAIRMAN LEVI: I don't think it has to.
- 20 MR. KECKLER: No. I don't think it has to be
- 21 the day.
- 22 CHAIRMAN LEVI: It could be the early fall.

- 1 MR. KECKLER: Yes.
- 2 CHAIRMAN LEVI: But I think it's very
- 3 important, in what Martha and Gloria and Julie started
- 4 to talk about, which is really helping us fill in the
- 5 blanks, is, well, what should this year include, and
- 6 what kinds of things when, and who hosts them? They
- 7 shouldn't all be in Washington. We're
- 8 Washington-funded, but we're out in the country.
- 9 Yes?
- 10 DEAN MINOW: I do also view this as a very
- 11 important opportunity to address one of the first
- 12 elements of the strategic plan, which is the public
- 13 education. So that's why I think it's important to
- 14 think about the message.
- 15 It's not simply being fundraising. I think
- 16 it's about lifting up the value of legal services, the
- 17 history, the bipartisanship, the stories of people,
- 18 what they have done. And I would make that the
- 19 centerpiece of this year.
- 20 CHAIRMAN LEVI: I agree. The fundraising
- 21 here -- in terms of our overall budget, the objective
- 22 here, if you added all of these things up, I think it's

- 1 around \$15 million, which is very small in terms of our
- 2 overall budget.
- 3 Yes, Herb?
- 4 MR. GARTEN: Following up on Martha's
- 5 comments, the big change in the last ten years, Access
- 6 to Justice Commissions throughout the country. And we
- 7 ought to focus in that.
- 8 DEAN MINOW: That's great.
- 9 CHAIRMAN LEVI: I think that's great.
- 10 MS. REISKIN: This just popped into my head.
- 11 I'm wondering if we could maybe identify the 40 people
- 12 that have done the most to advance it, and have a
- 13 nomination process and honor them somehow.
- 14 DEAN MINOW: That's interesting.
- 15 MS. REISKIN: Because I know there's more than
- 16 40, but there's so many people that have dedicated
- 17 their life to this and have done such amazing work.
- 18 DEAN MINOW: You could have honorary mentions
- 19 for everybody else.
- MS. REISKIN: Yes.
- 21 DEAN MINOW: That's nice.
- MR. MADDOX: Can you do it next year during

- 1 March Madness? We could have, you know, like the
- 2 brackets.
- 3 (Laughter.)
- 4 MS. REISKIN: That could be the fundraiser, we
- 5 bet.
- 6 MR. MADDOX: Seriously.
- 7 DEAN MINOW: The whole thing could be virtual.
- 8 MR. MADDOX: Right. It might generate a lot
- 9 of interest.
- 10 DEAN MINOW: That's interesting. It is
- 11 interesting.
- 12 CHAIRMAN LEVI: It's hilarious. It actually
- 13 is interesting. Thoughtful.
- 14 DEAN MINOW: Use the modern technology.
- 15 CHAIRMAN LEVI: Well, yes. He's with tongue
- 16 in cheek, but serious.
- 17 MS. RHEIN: That was actually, I think, a
- 18 really interesting idea.
- 19 CHAIRMAN LEVI: I do, too. Yes.
- 20 MS. RHEIN: Can I address just a couple of
- 21 quick things?
- 22 CHAIRMAN LEVI: Sure, Wendy.

- 1 MS. RHEIN: I know I'm not even officially
- 2 starting yet, but just a couple of points I wanted to
- 3 raise.
- 4 It's very difficult to raise money without
- 5 public awareness. So I think those things have to go
- 6 hand in hand. And it will be very important to honor
- 7 the past as well as looking for a strategic direction
- 8 for the future.
- 9 But there are some fantastic ways, whether
- 10 it's some kind of a virtual time capsule, or looking at
- 11 different ways of doing three-minute interviews with
- 12 distinct people that have had achievements over the
- 13 past 40 years on the field level, clients -- engage
- 14 people so that you have even a dedicated website to the
- 15 40th anniversary that would be linked.
- 16 And you could have short videos. You could
- 17 have a bracket system. You could have all different
- 18 kinds of elements, and refresh that once a week to
- 19 engage donors and to engage other people to attend
- 20 events throughout the time.
- 21 CHAIRMAN LEVI: This is why we have you.
- DEAN MINOW: That's great. That's terrific.

- 1 MS. RHEIN: So this is a fantastic opportunity
- 2 for both public awareness as well as engaging funders.
- 3 CHAIRMAN LEVI: And then the other thing, is
- 4 what can we leave in its wake?
- 5 MS. RHEIN: Yes. This is just a starting
- 6 point to be able to kick off a continuing career, being
- 7 able to have private funders.
- 8 CHAIRMAN LEVI: So with that, do we have any
- 9 public comment? Terry, you're going to come up and
- 10 make a donation?
- 11 (Laughter.)
- 12 MR. BROOKS: Terry Brooks with the American
- 13 Bar Association for the record. And I just want to
- 14 echo all of the good things that have been said around
- 15 the table about the importance of noting this
- 16 anniversary.
- 17 As you all know, the ABA was instrumental in
- 18 helping to create the Corporation, and many of the
- 19 leaders who were involved in that have unfortunately
- 20 passed -- Reece Smith, Bill McCalpin, who this complex
- 21 is named after, and others.
- But there are some who remain with us, and I

- 1 hope we can recognize their contributions at that time.
- 2 And I hope that as planning goes forward, you'll reach
- 3 out to the ABA and involve the organization at the
- 4 highest levels in terms of recognizing the
- 5 contributions of all.
- 6 To Charles' point of selling a date and a
- 7 time, ABA leadership, unfortunately, changes the 1st of
- 8 August each year. So it will be helpful to know as
- 9 soon as possible when the main event will be so that we
- 10 can begin to engage appropriate leadership throughout
- 11 the organization.
- 12 CHAIRMAN LEVI: Well, I'm told that next
- 13 year's August ABA annual meeting is in, of all places,
- 14 Boston, Massachusetts. So it struck me that the
- 15 combination of Harvard Law School and the ABA being in
- 16 Boston was an opportunity to have our Vice Chair and
- 17 the ABA together do something of importance in Boston.
- 18 But I'm just throwing that out there.
- No humor here.
- 20 (Laughter.)
- 21 CHAIRMAN LEVI: In any event, we
- 22 absolutely -- as far as I'm concerned, yes. And I

- 1 assume that with the desire to be contributing in
- 2 thoughtful ways also will come the dollars behind that
- 3 as well. So we very much appreciate that and look
- 4 forward to working with the ABA, as we have been. And
- 5 our Board has been collaborating with the ABA, as you
- 6 know. So thank you, Terry.
- 7 MR. BROOKS: Thank you.
- 8 CHAIRMAN LEVI: Any other public comment?
- 9 (No response.)
- 10 CHAIRMAN LEVI: Any other business?
- 11 (No response.)
- 12 CHAIRMAN LEVI: Then we'll move into a closed
- 13 session. And that means that some of you in the room,
- 14 unfortunately, have to take a brief exit. And that
- 15 does not mean for executive staff of the LSC or for the
- 16 board members, but it does mean for the general public.
- 17 (Whereupon, at 9:34 a.m., the Committee
- 18 adjourned to executive session.)
