- 1 PROCEEDINGS
- (4:10 p.m.)
- 3 CHAIRMAN LEVI: I'd like to call the meeting
- 4 to order, and get a motion to approve the agenda.
- 5 MOTION
- 6 MR. GREY: Move it.
- 7 CHAIRMAN LEVI: Second?
- 8 MR. STRICKLAND: Second.
- 9 CHAIRMAN LEVI: All in favor?
- 10 (A chorus of ayes.)
- 11 CHAIRMAN LEVI: Okay. So the second item is a
- 12 discussion of fundraising objections. Well, the Board
- 13 ratified these objectives, which I think was a good and
- 14 important step.
- 15 And now it seems to me that
- 16 particularly -- and Wendy, I don't want to put this
- 17 before your arrival, but I feel a sense of urgency in
- 18 needing to get these funding for the 40th anniversary
- 19 to start thinking about how we would go about that and
- 20 what combination of things because if we were to
- 21 envision a 40th anniversary year that goes April to
- 22 April, now we're talking eleven months from now.

- 1 MS. RHEIN: Yes.
- 2 CHAIRMAN LEVI: So I'm thinking that it's an
- 3 important opportunity to bring the 134 executive
- 4 directors, their board chairs, most state bar
- 5 presidents, IOLTA people, access to justice commission
- 6 heads, state supreme court chiefs, and what have you
- 7 down probably to Washington for not just a celebration,
- 8 but for a serious set of well-out-together,
- 9 well-conceived meetings.
- 10 So there's a double track here. But that
- 11 can't take place without some good planning. Squaring
- 12 up people's calendars requires planning. But then
- 13 accommodating and paying for a space -- NLADA does it,
- 14 I know -- how much we need to raise in order to
- 15 accomplish that.
- And then if we were going to have a series of
- 17 other out-of-Washington events, maybe not as elaborate
- 18 but nevertheless of significance, because if there's an
- 19 opportunity to tell our story, and we want to make sure
- 20 it's -- well, with the number four, that's four bases.
- 21 I want it to be a grand slam.
- 22 So if we could think about different models,

- 1 funding models, whether it's law firms stepping up and
- 2 taking 50- and 25,000, the way David Stern does it, or
- 3 do we also want to enmesh some of the other objectives
- 4 here into it, and so we create even larger buckets
- 5 because we're hoping to try to have one ask that
- 6 encompasses all of this?
- 7 So Wendy, I don't know. It's unfair to put
- 8 that to you before you even are on the clock. But I'm
- 9 doing that. But I'm not holding to anything. That's
- 10 where I think we need to be. And in a few weeks you
- 11 will be on the clock, and then we really do need to get
- 12 going. But that's what's in front of us.
- 13 MS. RHEIN: Right. I think one of the first
- 14 things that I would like to do, once I actually do
- 15 start on May 6th, is to be able to start putting
- 16 together with you all a calendar of both the large
- 17 events and the small events, and then looking at
- 18 different funding models, different funding
- 19 opportunities -- regionally, nationally, the larger
- 20 corporate sponsorship kinds of things for an event
- 21 versus small workshops that may have a more nuanced
- 22 funding base.

- 1 So I think that once I have a better sense of
- 2 the program areas and we start mapping out a full
- 3 year's calendar, we can look at individual asks.
- 4 CHAIRMAN LEVI: Yes. One thing that people,
- 5 when we adjusted our meetings now, came up to me and
- 6 said, you know, the issue of conferences in Washington
- 7 is that spring is very popular; summer, understandably,
- 8 because it's so unpleasant there, not so popular.
- 9 But we run into an election year in the fall,
- 10 and I don't really want us to get enmeshed in that. So
- 11 some folks thought, well, if you're going to kick it
- 12 off in April, you ought to kick it off. That should be
- 13 your big event. But if the timing doesn't work and we
- 14 need to slide that out, which we could, we could do it
- 15 in September. But you're in the election season at
- 16 that point.
- 17 MS. RHEIN: I think either one would be an
- 18 option to look at. I wouldn't push it beyond the end
- 19 of October because then you get into the holiday season
- 20 and that becomes all the more difficult. April is
- 21 certainly an option, but it would be a lot to pull
- 22 together in a year's time.

- 1 CHAIRMAN LEVI: Okay. That's what I think.
- MS. RHEIN: Yes.
- 3 CHAIRMAN LEVI: Go on. Jim?
- 4 PRESIDENT SANDMAN: Yes.
- 5 CHAIRMAN LEVI: Someone else had a comment?
- MS. ROK: Wendy, did you have more to say?
- 7 MS. RHEIN: No. That was all.
- 8 MS. ROK: Oh, okay.
- 9 CHAIRMAN LEVI: Did anybody else in the room
- 10 or on the phone?
- 11 MS. ROK: Not in the room.
- 12 MR. GARTEN: I don't fully understand what the
- 13 effect the election would have on the choice of dates,
- 14 John.
- 15 CHAIRMAN LEVI: It's just that -- and I may be
- 16 wrong. The election may not -- the question is, will
- 17 people feel that it's being lost in the election season
- 18 hyperbole? Will people get wrapped up in that? Will
- 19 certain folks becomes unavailable?
- 20 But I don't really -- my own sense, and I put
- 21 this out there -- this was just people talking to me
- 22 about it just now when we were in Washington for our

- 1 board meeting. I had thought that September really was
- 2 going to be an easier possibility for us, that
- 3 April -- but how would we open the year? I don't think
- 4 we want to do it in late October. I think --
- 5 MR. GARTEN: Well, September is a good time.
- 6 And we want to give consideration to what's available
- 7 hotel-wise and meeting space-wise.
- 8 CHAIRMAN LEVI: Right.
- 9 MR. GARTEN: There is a relatively new area
- 10 called National Harbor on the Maryland side of the
- 11 Potomac that is a very nice place and very well
- 12 equipped for meetings, with nice hotels and good
- 13 restaurants. It's like a little town. I don't know
- 14 whether you've ever been there or not.
- MR. STRICKLAND: I've been there to a very
- 16 large meeting. They can host most any size meeting.
- 17 MR. GARTEN: That's correct. So anyway, it
- 18 may be difficult to arrange meeting rooms and hotel
- 19 rooms at what may now be within a year.
- Wendy, what do you have to say about that?
- MS. RHEIN: You know, I think that it's
- 22 certainly possible to do. We would want to look at the

- 1 sheer quantity of people and the kind of meeting space.
- 2 National Harbor is beautiful, and they do have a huge
- 3 variety of both hotel space and meeting space, so that
- 4 would certainly be an option.
- In the springtime in D.C., it's usually
- 6 difficult because of cherry blossoms and hotel rooms.
- 7 But if you're talking about blocking a large section of
- 8 one hotel, they're more often accommodating for that
- 9 than for individual one-off hotel rooms.
- 10 So I certainly think we could look at both.
- 11 That's a quick and easy thing to do, to find hotel room
- 12 availability.
- 13 CHAIRMAN LEVI: Okay. The other is, the
- 14 reason that I threw out April -- and I know April's a
- 15 push -- but I hear it quite frequently that our
- 16 executive directors and their board chairs have
- 17 been -- it's been a long time since they were together
- 18 in a space on behalf of LSC.
- 19 They may have gone to the NLADA or other
- 20 larger gatherings. But that core group that is really
- 21 our programs have not been together in a long time. I
- 22 don't know when the last time that was. Maybe it was

- 1 the 30th.
- MR. STRICKLAND: I think it was, John.
- 3 PRESIDENT SANDMAN: I think it was 2008.
- 4 CHAIRMAN LEVI: You do?
- 5 PRESIDENT SANDMAN: Yes.
- 6 CHAIRMAN LEVI: What happened in 2008?
- 7 PRESIDENT SANDMAN: There was a conference
- 8 here, not at LSC but at the Marriott across the Key
- 9 Bridge.
- 10 CHAIRMAN LEVI: Frank, do you remember that?
- 11 MR. STRICKLAND: I do remember something at
- 12 the Marriott at the Key Bridge. But for some reason, I
- 13 was relating it to the 30th. So I could be mistaken.
- 14 I'll yield.
- 15 MR. GARTEN: I think there was a conference
- 16 for the local people here in Washington that --
- 17 MR. STRICKLAND: Yes. I believe that's -- we
- 18 had very close to total attendance by all the EDs.
- 19 MR. GARTEN: That's correct.
- 20 MR. SCHANZ: I can clarify that. This is Jeff
- 21 Schanz. That was my first year here. I was invited
- 22 only to hear Helaine Barnett speak. I wasn't invited

- 1 to the entire conference because it was all the EDs.
- 2 And after the first half hour or first half day, I was
- 3 excused from the proceedings.
- 4 But I did hear Helaine speak. It was at the
- 5 Key Bridge Marriott, right across the river. And I was
- 6 invited and disinvited at the same time.
- 7 MR. GARTEN: I don't recall being there as a
- 8 board member. Frank, do you?
- 9 MR. STRICKLAND: I don't know whether I stayed
- 10 for the whole conference. I may have had a short
- 11 speaking part to welcome them to D.C. or something like
- 12 that. But to just -- I was excused after that.
- 13 CHAIRMAN LEVI: I have a different -- I see.
- 14 Well, I have a different model in mind. Was that in
- 15 connection with the 35th?
- MR. STRICKLAND: No.
- 17 CHAIRMAN LEVI: It just happened?
- 18 MR. SCHANZ: It was ostensibly training for
- 19 the EDs.
- 20 CHAIRMAN LEVI: Oh, okay. Well, so it's been
- 21 a long time, in any event, and certainly not under
- 22 Jim's or our leadership, and apparently only half under

- 1 Jeff's.
- 2 MR. GARTEN: I think it would have to be
- 3 either in April or September, and April is the
- 4 preferred date, obviously.
- 5 CHAIRMAN LEVI: Not if it's -- only if April
- 6 can really be good.
- 7 MR. GARTEN: Oh, absolutely. I agree
- 8 completely.
- 9 CHAIRMAN LEVI: Yes. Well, that's --
- 10 MR. GARTEN: I personally don't see any
- 11 problem -- it's the anniversary year -- whether it's
- 12 April or September.
- 13 CHAIRMAN LEVI: Right. And then the issue
- 14 of -- and part of this is, do we get firms to kick in
- 15 25,000 and 10,000 and 5,000, or are we looking -- to
- 16 support those kinds of events? Or are we also thinking
- 17 that they might also want to contribute to some of
- 18 these other buckets?
- 19 That's where, Wendy, we'll really have to have
- 20 a serious set of conversations, and about the other
- 21 prospective funders.
- MS. RHEIN: Right.

- 1 CHAIRMAN LEVI: Because if we were going to
- 2 honor some prospective funders, even, then you might
- 3 need the time to get them to fund and then be able to
- 4 honor. And that certainly argues for September, too.
- 5 MS. RHEIN: Uh-huh. Or if you have other
- 6 honorees who are not funders but you want to engage
- 7 their circle, that will take a little bit of time, too.
- 8 CHAIRMAN LEVI: Right. Exactly.
- 9 MR. GARTEN: This could also be advertised or
- 10 told as a kickoff for a campaign.
- 11 CHAIRMAN LEVI: Yes.
- 12 MR. GARTEN: Of course, you'd have to be
- 13 assured that you have some leaders of that campaign,
- 14 that there are some funds that you've tied down, I
- 15 think, before you'd --
- 16 CHAIRMAN LEVI: Yes.
- 17 MR. GARTEN: And Wendy, you would know more
- 18 about this than me. But usually, when they have a
- 19 campaign that I have been involved with --
- 20 CHAIRMAN LEVI: Get half the money in.
- 21 MR. GARTEN: -- we've tied down substantial
- 22 funds.

- 1 CHAIRMAN LEVI: Right.
- MS. RHEIN: Yes. Ideally, you'd have 50
- 3 percent of it committed.
- 4 MR. GARTEN: Right.
- 5 MR. STRICKLAND: That's right.
- 6 CHAIRMAN LEVI: Well, I want to have a brief
- 7 conversation, then. That's sort of the numbered item
- 8 2.
- and so we don't run over here, on the
- 10 fundraising policies, we certainly at the board meeting
- 11 had a lot of discussion about those, and what we're
- 12 going to have to do on gift acceptance, and our
- 13 statements as it regards to anonymity.
- I do not know whether there are any
- 15 fundraising policies currently in place. There is a
- 16 gift acceptance policy, I think. But I would ask,
- 17 Wendy, if you could take a look at that stuff, too.
- 18 You'll probably have to advise us. And maybe this is
- 19 an OLA issue as well.
- 20 But clearly, we're going to need to have some
- 21 articulated, understandable policies that the folks
- 22 that are doing fundraising understand before they go

- 1 out and ask for the money and embarrass themselves.
- 2 MS. RHEIN: Sure. I can look at that.
- 3 PRESIDENT SANDMAN: This is Jim. We also have
- 4 to make sure we're in compliance with state
- 5 solicitation rules and are taking steps to follow up on
- 6 that.
- 7 CHAIRMAN LEVI: Right. And that we register
- 8 where we need to.
- 9 MS. RHEIN: Is LSC registered in any states at
- 10 this point for solicitation, Jim?
- 11 CHAIRMAN LEVI: I think it is.
- 12 PRESIDENT SANDMAN: Only in D.C.
- MS. RHEIN: Oh, okay.
- 14 CHAIRMAN LEVI: Well, we'd better get Illinois
- 15 registered quick.
- 16 (Laughter.)
- 17 CHAIRMAN LEVI: How long does that
- 18 registration process take?
- 19 MS. RHEIN: It's very long --
- 20 PRESIDENT SANDMAN: It shouldn't take long.
- 21 MS. RHEIN: It depends on the state and their
- 22 own processing, but not long.

- 1 PRESIDENT SANDMAN: There is a central service
- 2 you can use to file multiple applications at the same
- 3 time, and that's what we plan to do.
- 4 CHAIRMAN LEVI: Okay. Any other discussion on
- 5 fundraising policies?
- 6 (No response.)
- 7 CHAIRMAN LEVI: Public comment?
- 8 (No response.)
- 9 CHAIRMAN LEVI: Other business?
- 10 (No response.)
- 11 CHAIRMAN LEVI: I have a question for you. Do
- 12 we want to have a closed session today, or do we feel
- 13 we should wait till Wendy is only, really, to have
- 14 another closed session here as it relates to this?
- 15 MR. GARTEN: I think it would be better to
- 16 wait.
- 17 CHAIRMAN LEVI: That's sort of my sense. What
- 18 do you think, Robert or Frank?
- 19 MR. STRICKLAND: I tend to agree with that.
- 20 CHAIRMAN LEVI: Jim, do you feel like we need
- 21 to have a closed session today?
- 22 PRESIDENT SANDMAN: I don't. I don't know

- 1 that we have much additional to discuss beyond what
- 2 we've taken up in the prior meetings.
- 3 CHAIRMAN LEVI: Yes. Unless you had any news
- 4 of any kind based on any discussions with any
- 5 individual donor or what have you. I have nothing to
- 6 report.
- 7 PRESIDENT SANDMAN: I don't, either.
- 8 CHAIRMAN LEVI: Okay. So then what about just
- 9 a motion to adjourn, and we don't have the closed
- 10 session?
- 11 MR. GARTEN: I move we adjourn.
- 12 CHAIRMAN LEVI: Atitaya, are we allowed to do
- 13 that?
- MS. ROK: Yes.
- 15 CHAIRMAN LEVI: Then I'll entertain a motion
- 16 to adjourn.
- 17 M O T I O N
- MR. GARTEN: I so move.
- MR. STRICKLAND: Second.
- 20 CHAIRMAN LEVI: All in favor?
- 21 (A chorus of ayes.)
- 22 CHAIRMAN LEVI: Thank you all.
