

## New HotDocs Charitable Organization Program

Dear HotDocs User,

As many of you are aware, HotDocs Limited (formerly Capsoft UK LTD) acquired the HotDocs software business from LexisNexis in November 2009. As a result of the acquisition, the LexisNexis software donation program, of which your organization may have previously been a beneficiary, has been dissolved.

However, HotDocs Limited, through our U.S. business, HotDocs Corporation, welcomes the opportunity to continue using HotDocs software to support charity and community initiatives, by introducing the HotDocs Charitable Organization Program.

All recipients from the previous donation program, as well as other eligible organizations developing online document assembly templates in conjunction with Pro Bono Net's *Law Help Interactive* program, will be eligible for free copies of *HotDocs Developer 10* and *HotDocs User 10* (a desktop application for accessing and deploying templates built on *Developer*) along with 30 days of free Installation Support\*. These products were formerly known as *HotDocs Pro* and *HotDocs Standard*.

These licenses will never expire or require reapplication. *This offer will expire the 31st of August 2010.* After such time, your organization will be determined as outlined below.

Following August 31, 2010, any new organization that meets eligibility for the Charitable Organization Program (see Note 1) will be able to buy licenses at a 70% discount from the list price of *HotDocs Developer 10* and *HotDocs User 10* along with 30 days of free Installation Support\*.

Additionally, an annual Maintenance & Support program is now available to all former recipients under the LN program, or any new charitable organizations who wish to apply (see Table 1).

The HotDocs Maintenance & Support program will entitle a nominated member of your organization to gain access to telephone support from our Technical Support team. You will also be entitled to receive all new version upgrades and fixes to the HotDocs software.

Submissions must include a one page summary of your organization with a copy of your IRS determination letter or current Form 990. Submissions additionally must specify which HotDocs software is requested (*HotDocs Developer 10* or *HotDocs User 10*) with the number of software licenses needed (see Note 2). Submit documents to:

Note 1

Eligibility for the HotDocs Charitable Organization Program includes those legal service organizations funded by the Legal Services Corporation (LSC), organizations funded by their state Interest on Legal Trust Account (IOLTA), or equivalent charitable organizations that assure HotDocs products will be used exclusively for not-for-profit efforts.

Note 2

If your organization is a recipient and funded by the Legal Services Corporation (LSC), you are NOT REQUIRED to submit verification of eligibility, however, you are required to submit which HotDocs software is required (*HotDocs Developer 10* or *HotDocs User 10*) with the number of software licenses needed.
